Sealed tenders affixed with revenue stamp worth Rs. 5/- are invited from registered dealer /suppliers for the supply of the material . The tenders must reach this office by or before 09-02-2013. The list can be downloaded from the website www.itishopian.org The rates should be quoted FOR Institute and the specification as required. The undersign reserves the right to accept or reject any quotation without assigning any reason. The tenders will be opened on next working day in presence of the tenderers who wish to be present.

Terms and Conditions:

- 1 The tender must be sealed in double cover .
2. Bidder/tenderer must quote specification of each item failing which the tender shall be rejected.
- 3 The Chairman IMC-ITI Shopian reserves the right to accept or reject any tender or part thereof without assigning any reason.
4. In case, the successful bidders fails to supply the ordered items in full, penalty @ 2%(Two percent) of the total cost of the order shall be imposed upon him/them.
5. The inspection/verification of the Material will be carried out in this Institute by the Verification Committee.
- 6 Rates should be strictly quoted inclusive of all taxes(VAT, Entry Tax, other taxes etc. freight levies applicable at the time of supplies and quoted **F.O.R ITI Shopian** premises.
- 7 The rates are quoted only against the specified items. In case of specifications, the committee shall have the right to take decision at the time of finalization of rates.
- 8 The rates should be typed both in figures and words clearly without any cuttings/erasing . No such rates wherein any cuttings/ overwriting is/are found will be considered for comparison.
- 9 Each offer/tender shall be accompanied with a Call Deposit Receipt equal to 2% of total cost of tender from any scheduled bank pledge to the “Chairman IMC-ITI Shopian which will be returned immediately in case of un-successful tenderers.
- 10 The Bids/tenders must reach either under sealed registered cover or deposited in the office of Superintendent, (Member –Secretary IMC) Govt. Industrial Training Institute, Batapora Shopian District Shopian -Kashmir by or before 9th of Feb , 2013 up to 2.00 PM on working days only. Tenders to be received after due date shall not be entertained. The tenders will be opened on next working day at 2pm. In presence of tenderers who wish to be present.
